- B2 = Lowest offered price for preparation and operation of separators for separation of municipal from C&D waste x10 Offered price for preparation and operation of separators for separation of municipal from C&D waste
- B3 = Lowest offered price for loading of separated and unseparated waste into transport vehicles x 20 Offered price for loading of separated and unseparated waste into transport vehicles
- B4= Lowest offered price of waste transport x20
 Offered price for waste transport
- B5= <u>Lowest offered price for recultivation service x 20</u>
 Offered price for recultivation service
 - B = Total weighted points = B1+B2+B3+B4+B5

Most favourable tender will be the one with most weighted points.

2. Elements of criteria, i.e. the way based on which the Contracting Authority will award the contract in situations when there are two or more tenders with the same number of weighted points

If two or more tenders have the same number of weighted points, the Contracting Authority will award the contract to the tenderer selected in a draw. The draw will include those two tenders that have the same number of weighted points. Drawing will be conducted by the Contracting Authority in public procedure, in presence of tenderers, by writing the names of tenderers in separate papers of the same size and colour, and putting all such papers into a transparent box, wherefrom only one paper will be drawn out. The tenderer whose name appear on the drawn paper will be awarded the contract. The minutes from the drawing session will be delivered by the Contracting Authority to tenderers personally, and to others, not present at the session, electronically within three days' time.

HOW TO SUBMIT THE TENDER AND DEADLINE FOR THE SUBMISSION

The tender shall be submitted in closed envelope or box, in such way that makes it obvious that it is opened for the first time at the opening session, with the following wording "TENDER for the open procurement procedure – Procurement of service of cleaning up and removing dumpsites scattered around the area, no. XI-13-404-251/2018 – DO NOT OPEN".

The tender shall be deemed timely delivered in received by the Contracting Authority by 21.12.2018, by 10:00 hours.

On the back of the envelope or box, the name and address of tenderer shall be written, as well as phone number, name and surname of authorised contact person.

The Contracting Authority, on the receipt of the tender, will register the date and time of the receipt.

Deadline for the submission of tenders shall be 21.12.2018, by 10:00 hours.

The tender submitted upon the expiry of the above deadline, shall be deemed untimely one, and the Contracting Authority shall return such tender unopened to the tenderer, stating that the tender was submitted untimely.

Within the deadline for submission, the tenderer is entitled to change, supplement or revoke their tender, in the way defined for the submission of tenders.

Upon the expiry of deadline for submission of tenders, the tenderer cannot revoke or change their tender.

VENUE, TIME AND MANNER OF OPENING OF TENDERS

Opening of tenders shall be conducted on 21.12.2018 at 10:15 hours, on the premises of the City Administration of Pančevo, Secretariat for Procurements, Office no. 3, Pančevo, Trg kralja Petra I no. 2-4.
