Subject of Public Procurement No. IX-13-404-245/2019 is a public procurement for selection of private partner and award of public contract on public-private partnership without elements of concession, for financing, construction and maintenance of road infrastructure on the territory of the City of Pančevo, with public payment

Scope of this public -private partnership is conferring of the public service of maintenance of

streets and roads on the territory of the City of Pančevo by financing, construction and maintenance of local road infrastructure, with public payment.

The Contract is concluded for a period of 10 years.

Number of lots, if the subject of procurement is formed in multiple lots: Procurement is not formed in lots.

Criterion, criterion elements for award of contract:

The criterion for selection of the best offer, in accordance with Art. 85 of the law on public procurements will be:

"Economically most advantageous offer" which will be obvious from the criterion of the offered price which includes total annual compensation for making road infrastructure available, for the private partner, without VAT, and price reduction from the Contracting authority Price List.

Means of financial warranty:

As a **means of warranty for seriousness of the offer**, the private partner is obliged to submit original bank warranty. The bank warranty shall amount to 120,000.00 EUR, specifying that it is irrevocable, unconditional, payable at first request and without right to objection, with a validity period of 120 days longer than the day of the tender opening session.

Means of financial warranty is submitted for the purpose of protection of the Contracting Authority who will activate the means of financial warranty in case:

- Selected bidder gives up the offer or fails to sign the contract,
- Bidder refuses to pay the cost of testing samples delivered with the offer if the testing shows that tested parameters deviate from the requested values,
- Bidder withdraws, revokes or changes the offer after the deadline for offer delivery,
- Selected bidder does not sign the Contract on public procurement in due time,
- Bidder provides false data in the offer,
- Selected bidder (Supplier) does not deliver good job performance warranty in accordance with the requirements from the Tender package documents and the Contract.

The Contracting Authority will return the means of financial warranty for seriousness of the offer to those bidders with whom contract is not concluded, within 15 days from the date of contract conclusion with the Selected Bidder. The Contracting Authority will return to the Selected bidder his means of financial warranty for serousness of the offer after conclusion of the contract, under the condition that the Selected Bidder delivers a bank guarantee for good job performance in the period of implementation, within 15 days from the date of public contract concluding.

For the purpose of **ensuring good quality of performed activities**, the Supplier is obliged to provide a bank warranty for good job performance in the period of implementation, namely: one original bank guarantee **which shall amount to 100,000.00 EUR**, specifying that it is irrevocable, unconditional, payable at first request and without right to objection, with a validity period of 30 days longer than the planned period of implementation.

For the purpose of **ensuring performance of activities**, the Supplier is obliged to provide a bank warranty for good job performance **in the period of implementation of the complete contracted service**, namely: one original bank guarantee **which shall amount to 80,000.00 EUR**, specifying that it is irrevocable, unconditional, payable at first request and without right to objection, within 15 days from the start of the calculation period which is a period of one year in which the complete contracted service is provided, with a validity period 30 days longer than the planned duration of the calculation period.

Manner of bidding and deadline for delivery of offer:

The bidder submits his offer directly or by post, in a sealed box or envelope, closed in such a way that it can be safely determined during tender opening session that it is opened for the first time.

The back of the envelope i.e. the box must contain full name and address of the Bidder.

In case the offer is submitted by a group of bidders, the envelope/ box needs to specify that the offer is a group offer, and names and addresses of all participants in the group offer must be stated on the envelope/box.

Offers are to be delivered to the following address: Trg kralja Petra I 2-4, 26000 Pančevo, with a note: "Bid in the open public procurement for selection of private partner and award of public contract on public-private parthership without elements of concession, for financing, construction and maintenance of local road infrastructure on the territory of the City of Pančevo, with public payment, JN No. XI-13-404-245/2019 - DO NOT OPEN".

The bid is considered timely if it is received by the Contracting Authority by 27.02.2020 by 09:00am Mid-European time at the latest.

Place, time and way of opening offers: The public tender opening session will be performed by the Commission of the day of **27.02.2020**, at 09:30am Mid-European time, on the premises of the Pančevo City Administration building at Trg kralja Petra I 2-4, 26000 Pančevo, ground floor office No.3.

Conditions for participation of bidders' representatives in the tender opening session: The opening of offers is public and can be attended by any interested person. Only the authorized representatives of the bidders can actively participate in the tender opening process. Attending representatives of the bidders must submit to the Commission certified authorizations for participation in the tender opening procedure before the tender opening session starts.

Deadline for decision making: Decision on award of the contract will be made 40 days at the latest from the tender opening session date.
